Letter to the Editor: Still Regarding Causes of Death in an Acute Psychiatric Inpatient Unit of a Portuguese General Hospital

Dear Editor.

We read with great interest, in a previous issue of this journal, one article regarding the causes of death in an acute psychiatric inpatient unit of a Portuguese general hospital. It seems to be the first article in Portugal regarding such an important topic, so many times neglected in our small country's clinical practice and scientific literature. Besides this paper we had to travel back in time more than 25 years to find a similar article, although in an ambulatory community treatment. We have been working, for more than ten years, in what was once called a psychiatric asylum, and here we have a completely different reality. We have higher numbers, unfortunately, in our personal records (almost 2000 patients), with 50 deaths (2 suicides by hanging) in ten years of time-span (2008 February 1st). This means an average of 5 deaths per

year, and all deaths were confirmed at the national online electronic health registry Registo de Saúde Electrónico (RSE), previously known as Plataforma de Dados de Saúde (PDS). This RSE platform3 is very useful, to confirm, among other things, the death of our patients in times of austerity,4 but it doesn't allow us to find the cause of death. We hope that one of these day the causes of death, compiled at the national system of death certificate - Sistema de Informação dos Certificados de Óbito (SICO)5 - will be crossed with the RSE and publicly available online, for clinicians. That would be extremely useful and would allow us to work on better studies regarding the mortality of our patients. Meanwhile we would like to invite all readers to submit their works regarding mortality in their psychiatric patients in other settings (e.g. the acute patients' wards in the psychiatric hospitals or the chronic patients' wards in the religious charity institutions) where thousands of Portuguese patients still receive (the only) treatment for their mental illness. We could try guessing that there are some numbers deserving publication and comparison with other countries. Only then, with a better knowledge of our mortality rates we will be able to improve the mental health care in Portugal.
